What is the current rental rate paid to the district by the current provider?

No rental rate is paid to the district for the use of the facilities.

Under Proposal Presentation (Page 21). Do you have a NY State license to operate childcare? If yes, what is the licensing agency and provide the name and contact information for the agency? My question- We operate in 10 States and the District of Columbia. All our programs are either licensed or license-exempt, depending on the requirements of each state. We do not have any programs operating in NY for the 2021-2022 school year, however if awarded, we would become licensed to operate programming at each site, prior to the first day of school. Does this disqualify us from applying?

If you do not have a licensing agency, you would not be disqualified to apply. The winning bid would be expected to work with the Division of Child Care Services through the Office of Children and Family Services to register the after-school care program and apply for a license to operate the program in Lynbrook.

Why is this going out for bid?

The current contract has exceeded the number of extension years and as such requires a new bid.

Will programming take place at each of the 4 schools or just the 3 Elementary Schools?

A separate program will operate at each of the four elementary buildings (the Kindergarten Center, West End Elementary School, Marion Street Elementary School, and Waverly Park Elementary School).

What amount do parents currently pay for afterschool programming?

5 days per week \$289.00 per month 4 days per week \$245.00 per month 3 days per week \$202.00 per month 2 days per week \$143.00 per month 1 day per week \$96.00 per month

Parents pay monthly.
